E-Verify ej lale aolep meļeļe ko kwōj kwaļoki ilo Form I-9, Employment Eligibility Verification eo, im peba ko an Kien eo bwe ren lukkuun jelā elaňne kwōweppān ūn jerbal ilo Amedka in.

Kwōj bōk Leta in Lejok in jān jikin jerbal eo am bwe E-Verify ej kwaļok bwe meļeļe ko rej likūti ilo E-Verify jān Form I-9 eo eoktak jen meļeļe ko an SSA. Kwaar bōk juon 'SSA Kōjjelā ūn Rijerbal eo Ikijien Bōlen Jab Weeppān' im kwōj bebe in jumaeiki. Men in ejab meļeļe bwe ebōd meļeļe ko kwaar lejoki ūn jikin jerbal eo am im e jab kōnke kwōjab weeppān ūn jerbal ilo Amedka in.

Juon SSA Bōlen Jab Weeppān emaroň waļok elaňne:

2. Kwōj aikuj lojok SSA field opiji eo mokta jān **8 raan in kien bijnjī ko** ālikin raan in Leta in Lojok in, mokta jān / / (MM/DD/YYYY), ūn kōmmane keej eo am.

 - Elaňne ejab kwe juon U.S. citizen: kein kamoole **kadkadūm in legal alien ekkar ūn jerbal eo am (work-authorized legal alien status)**, waan joňak, juon Permanent Resident Card (Form I-551 ak "green card"), peba in Employment Authorization Document (Form I-766), ak Arrival-Departure Record (Form I-94) im ej kwaļok kadkadūm ekkar ūn kien.
